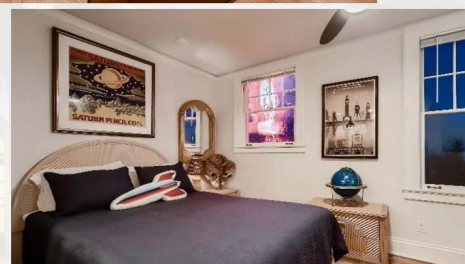
COMMUNITY REDEVELOPMENT AGENCY (CRA) UPDATES

CRA Grant Project - Launch Now Mixed-Use Development

The two buildings at 300-310 South Washington Avenue, both originally constructed in 1924, are contributing buildings to the National Registry of Historic Places in Titusville and a designated site within the Community Redevelopment Agency District. The buildings are over 2200 square feet and rest on .739/acre. Due to neglect, the buildings were nearly vacant in 2017. Launch Now, LLC closed on the property in 2017 and proposed the revitalization and rehabilitation of the properties to promote the economic, cultural, education, aesthetic and general welfare of the community.

By protecting, enhancing and upgrading these important historical buildings, history has been acknowledged while building for the future with the explicit goals of increasing the occupancy rates, economic vitality, and property values within the CRA. The renovation of the buildings into a mixed use of commercial and residential uses was completed in FY 2024.

This project includes twenty (20) boutique style apartments upstairs, and commercial, retail and office space on the ground floor. This project received \$140,000 in matching grant funding from the Titusville CRA, and approximately \$450,000 from the North Brevard Economic Development Zone to assist in the rehabilitation and revitalization of these historic properties. This completed project was over a \$6 million investment in historic downtown Titusville and the CRA.

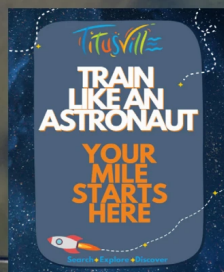

Is It Time to Rethink

The Indian River Lagoon Causeways?

Sixty years ago, engineers filled in roughly 80 football fields' worth of the Indian River Lagoon near Cape Canaveral. Their goal — create stable paths to connect elevated bridges leading to the beach. At the time, it made perfect sense.

Today, some scientists are questioning whether those thin strips of manmade land—often mistaken for causeways—are doing more harm than good.

What We Call "Causeways" Might Be Causing Problems

Technically, a causeway is a raised road built just above wet areas, not a long earthen barrier with bridges on top. Still, the term stuck, especially in areas like State Roads 520 and 528, where many pull over to watch rocket launches.

Now, some scientists believe these artificial land bridges might be contributing to the worsening health of the Indian River Lagoon, one of the most biodiverse estuaries in the world. Similar problems are appearing in other Florida coastal waters, clogged by aging infrastructure.

Are Causeways Choking the Lagoon?

Gary Zarillo, a researcher at Florida Tech, is among those studying the issue. His models suggest that removing sections of the SR 528 causeway—and potentially parts of SR 520—could significantly improve water circulation in the lagoon.

Across Brevard County, more than a dozen of these earthen strips restrict natural water flow, leading to stagnant zones. These areas often smell of rotten eggs due to the buildup of dying algae and hydrogen sulfide gas.

To explore potential solutions, Brevard County is planning a \$700,000 study that will evaluate different removal and redesign scenarios for the SR 528 causeway. The study will assess long-term benefits to water flow, wildlife, and storm resilience over the next 50 years.

Restoring Flow. Reviving the Lagoon

The Bennett Causeway over SR 528 was built in the 1960s to provide access to the barrier islands. But it also buried over 100 acres of the Banana River Lagoon, shrinking its width from over 10,000 feet to just 1,178 feet—and cutting off nearly 90% of natural water circulation in that area.

The upcoming study will examine a range of options, including:

- Full or partial removal of causeways
- Constructing new bridge spans
- Installing culverts or connection canals
- Dredging and natural restoration, like oyster beds and submerged plants

Though the project didn't make it onto this year's legislative funding requests due to its early stage, the county still plans to seek state, federal, and other local support.

Why It Matters: The Indian River Lagoon

The lagoon stretches along 40% of Florida's east coast and is home to more than 4,300 plant and animal species, many of them endangered or economically valuable. According to water management studies, every acre of seagrass supports about 40,000 fish and contributes over \$70,000 annually to the local economy.

But in 2020 and 2021, widespread seagrass die-offs caused a tragic mass starvation event for manatees, especially in Brevard County. Some experts blame the causeways for blocking the water flow that seagrass and marine life depend on.

The Debate Over Causeway Removal

Previous studies, like a 2020 analysis by the St. Johns River Water Management District, questioned the effectiveness of removing causeways. Models suggested that wind could stir up sediment on the lagoon floor, making the water cloudier and hurting seagrass recovery.

However, more recent research, including a successful removal of part of the Courtney Campbell Causeway in Tampa Bay, shows promise. That project, completed in 2018 at a cost of \$13 million, led to improved water quality and circulation.

Florida Tech's Zarillo believes earlier models underestimated key factors, like the influence of the Gulf Stream on lagoon dynamics. He says restoring natural flow could improve water exchange between the lagoon and the ocean, and even enhance hurricane evacuation by raising low-lying sections of road.

"There are lots of reasons to raise the causeways," Zarillo said. "It's not just about the ecosystem. It's about safety."

Where Innovation Takes *FLIGHT!*

Florida's Launch and Landing Facility Positions State as Global Aerospace Hub

KENNEDY SPACE CENTER, Fla. — On the edge of Florida's famed Space Coast, a once government-only runway is quietly shaping the future of space commerce. The Launch and Landing Facility (LLF), managed by Space Florida under a 30-year agreement with NASA, has become a cornerstone in the state's evolving aerospace economy — and a magnet for innovation.

With its 15,000-foot runway — one of the longest in the world — the LLF is now open to commercial customers, marking a sharp shift from its origins as a shuttle landing strip. Development at the site is designed to ensure Florida's leadership in the global space race continues, adding new capabilities and drawing a growing list of partners to the world's busiest spaceport.

Over the last four years, approximately \$63.8 million in state and federal grant funding has fueled rapid expansion at the facility. Backed by the Florida Department of Transportation through the Florida Spaceport Improvement Program, investments have included a mile-long utility corridor completed in 2022, opening new ground leasing opportunities for prospective tenants. Additional enhancements have focused on land preparation, Hangar Road construction to improve emergency access, and a completed wetland mitigation project.

The result is a facility now capable of supporting a wide array of activity, from suborbital flight training and satellite processing to horizontal takeoffs and landings by both aircraft and spacecraft. In 2023 alone, the LLF supported over 400 landings and departures, with missions including NASA's Crew 5, 6, and 7, SpaceX's CRS-25 and CRS-27, and the Axiom 2 crewed launch.

The LLF has also attracted a diverse group of tenants. Amazon's Project Kuiper has invested nearly \$140 million so far, which includes a satellite processing facility on site, supporting its plans to bring broadband to underserved regions via a new constellation in low Earth orbit.

"Expanding investments in Project Kuiper's infrastructure at Space Florida's Launch and Landing Facility not only reinforces our commitment to delivering reliable broadband connectivity to unserved and underserved communities worldwide, but also strengthens Florida's position as a hub for space innovation and job creation," said Brian Huseman, Amazon's vice president for public policy and community engagement. "We extend our sincere appreciation to Governor Ron DeSantis, Lieutenant Governor Jeanette Nuñez, and Space Florida CEO Rob Long for their leadership, and look forward to helping pave the way for a more connected future."

The LLF also serves as the arrival hub for delivery of heat shield's for Lockheed Martin's Orion crew module as part of NASA's Artemis project, while United Launch Alliance manages rocket stage deliveries. Supersonic jet firm Starfighters uses the runway for small satellite launches, and even automotive giants like Tesla, McLaren, Bugatti, and Volvo conduct aerodynamic testing and vehicle design enhancement research at the facility for their newest hypercars.

To support both its growing user base and its long-term vision, Space Florida continues to invest in infrastructure enhancements including land development for future tenants, runway access improvements, and significant power upgrades to nearby Launch Complex 46 to support both commercial and Department of Defense initiatives.

Looking ahead, the LLF offers prime aerospace-designated land for development, with opportunities for hangars, manufacturing, fueling stations, and passenger and operations facilities. The site's proximity

to rail lines makes it a strategic location for both orbital and suborbital operations, crewed or uncrewed.

Environmental responsibility is also woven into the facility's growth strategy. In compliance with the National Environmental Policy Act (NEPA), Space Florida has completed an Environmental Assessment to support sustainable development and future FAA license modifications. With its strategic location, modernized infrastructure, and commitment to environmental stewardship, the Launch and Landing Facility is positioning Florida not just as a launchpad — but as the engine room of a global aerospace future.

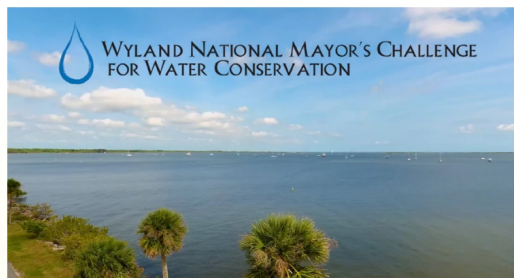

The City is excited to announce their participation in the 2025 Wyland National Mayor's Challenge for Water Conservation. This is a friendly competition between cities across the US to see who can be the most "water-wise." Mayors nationwide are challenging their residents to conserve water, energy and other natural resources on behalf of their city through a series of informative, easy-to-use pledges online. Installation of tree boxes downtown has begun. Tree boxes are a type of green stormwater infrastructure that are designed to collect the first flush of stormwater and treat it prior to discharge into the storm sewer system or to the subsoil. The structure is a pre-manufactured concrete box which is installed in-ground, filled with soil media and planted with native, non-invasive tree or shrub. The tree box functions as a compact bioretention system, which is a green infrastructure or low impact development stormwater control best management practice (BMP). In urban or built-out areas where space is limited, tree boxes can fit within a small existing footprint and as retrofit projects.

The City has received grant funding to install tree boxes near the Commons, City Hall, Brevard St. and Grace St. The project should be completed by the end of 2025



Work has begun on the Scobie Park living shoreline project. In partnership with the Brevard Zoo and the Indian River Lagoon National Estuary program grant funds were received to design and install a living shoreline at Scobie Park. The first phase of this project will include placing sand along the shoreline to repair erosion damage from the recent hurricanes and also installing coquina rock wave breaks in the water to help lessen future erosion.

The second phase will include planting of native grasses and mangroves along the shoreline to help stabilize shorelines, reduce erosion, and provide valuable habitat to enhance coastal resilience.



The City completed construction of two more baffle boxes designed to help the Indian River Lagoon. One along Hamilton Ave and the other at the end of Tuscarora Rd. The Nutrient Separating Baffle Box is a highly recognized storm water treatment system with two treatment zones. The first is a screen system that captures and holds leaves, trash, and debris and contains them within the box until they are cleaned out through regular maintenance. The second is a filtration system that includes a biosorption activated media to capture dissolved pollutants including nitrogen and phosphorus.

The city received grant funding for construction of both baffle boxes. This brings the number of baffle boxes installed in the City to 20.



Reaffirming its commitment to the environment, the City of Titusville has begun investing in a new fleet of hybrid vehicles in the first phase of a program intended to eventually replace its older fleet of traditional cars and trucks. This comes as the demand for reliable work vehicles has grown in recent years in conjunction with increased departmental workloads that has pushed the aging, fully gasoline-powered fleet to its limits.

Titusville City Council Members and city administrative leadership initiated this pivotal first step forward last year by investing in 20 hybrid vehicles. The new hybrid Ford F150 truck fleet is powered by two distinct modes of power: an internal combustion engine, and an electric motor for propulsion, a combination which has proven to increase fuel efficiency and reduce the emission of greenhouse gasses resulting in lower air pollution.

"The city's increased pursuit for implementing Titusville's sustainability action plan prompted our fleet replacement schedule to include hybrid vehicles," said Public Works Operations Director Sandra Reller. "Our hardworking team members appreciate this conscientious eco-friendly initiative and are excited to operate these new vehicles while they work

to serve our community," added Reller.

This decision represents is an upgrade and represents a powerful commitment to sustainability, reducing the city's dependency on fossil fuels and embracing the future of electrification. Currently, there are 14 new replacement hybrid vehicles in use by the Public Works Department, and their team members are better equipped to tackle essential tasks and ensure a cleaner, more efficient, and resilient community.



Land of Enchantment

Nestled in the southern part of Titusville, the Enchanted Forest is a hidden gem where towering trees and vibrant plant life create a serene, almost magical escape. Spanning 470 acres, the Enchanted Forest Sanctuary preserves a variety of natural habitats while offering educational experiences and a peaceful retreat for visitors of all ages. Conveniently located off Columbia Boulevard, it's an ideal destination for both locals and tourists to connect with Florida's native wildlife and explore its natural beauty.

Exploring the Sanctuary

A world of discovery awaits at the Enchanted Forest Sanctuary. Visitors can explore miles of scenic hiking trails beneath a lush canopy of trees—perfect for nature walks, photography, and quiet reflection. Along these tranquil paths, native flora and fauna from both temperate and subtropical zones thrive together, creating a uniquely diverse ecosystem.

The sanctuary features an array of natural habitats, including mesic and hydric hammocks, oak scrub, scrubby flatwoods, basin swamp and marsh, ruderal zones, and depression marshes. Wildlife sightings are frequent, with species such as the Eastern indigo snake, Florida scrub lizard, gopher tortoise, white-tailed deer, and the elusive bobcat all making appearances. Birdwatchers can delight in spotting the Magnolia Warbler, Downy Woodpecker, and Cooper's Hawk soaring overhead. Insect enthusiasts will also enjoy the colorful array of butterflies and dragonflies, especially in the educational garden near the center.

Eight unique trails wind through the sanctuary, ranging from the gentle 0.1-mile Enchanted Crossing to the more immersive 1.1-mile Magnolia Loop. Each trail offers scenic views and amenities like benches, interpretive kiosks, and overlooks. These trails are popular for hiking, picnicking, and geocaching.

At the heart of the sanctuary lies the Management & Education Center, a hub of learning and engagement. Designed to captivate visitors of all ages, the center includes interactive exhibits, a discovery room, a gift shop, restrooms, and a reference library for those eager to dive deeper into Florida's ecosystems. Outside, visitors can enjoy a vibrant butterfly garden and a screened amphitheater, ideal for outdoor educational programs.



Blending natural beauty with community-centered features, the Enchanted Forest Sanctuary also hosts a variety of local events—from plant sales and trail runs to arts and crafts nights and environmental fundraisers.



For a Good Cause

The success of the Enchanted Forest Sanctuary is rooted in Brevard County's Environmentally Endangered Lands (EEL) Program, which founded and continues to manage the site. Established in 1990, the EEL Program aims to protect Brevard County's natural habitats by acquiring environmentally sensitive lands for conservation, environmental education, and passive recreation. This initiative ensures the preservation of the region's rich biodiversity for generations to come. In partnership with the Friends of the Enchanted Forest, the sanctuary provides hands-on educational opportunities for all visitors—keeping admission to both the sanctuary and education center free and open to the public.

The EEL Program works closely with federal, state, and local partners committed to conserving natural resources and enhancing the region's quality of life. Sanctuaries under EEL management are carefully maintained to protect native habitats and support passive recreational activities such as hiking and wildlife observation, fostering a deep connection between people and nature.

The Friends of the Enchanted Forest, Inc. is a 501(c)(3) nonprofit composed of dedicated volunteers passionate about conservation and education. Their mission is to advocate for the protection of this unique natural area, raise public awareness about its ecological value, and provide volunteer support and funding to sustain the sanctuary for the long term.

Volunteers play a vital role in day-to-day operations, contributing their time and talents to tasks like greeting visitors, leading interpretive tours, managing exhibits, maintaining trails, and removing invasive species. Others assist with landscaping, photography, repairs, grant writing, newsletter creation, event planning, and even serving on organizational boards and committees. Their efforts ensure the sanctuary remains a vibrant, welcoming space for education, recreation, and conservation.

Five fire stations now protect Titusville as the city opened its first new station in four decades — Fire Station 14 — during a ribbon-cutting ceremony on February 28. On hand to mark this significant milestone in public safety were city leaders, residents, and public safety officials, and members of local media.

Among those in attendance were Mayor Andrew Connors, Vice Mayor Col. Herman Cole, USAF (Ret.), and Council Members Megan Moscoso, Jo Lynn Nelson, and Sarah Stoeckel and many other. Their collective presence underscored the city's unified commitment to strengthening emergency response and safeguarding a rapidly growing community.

Strategic Location and Enhanced Coverage

Located at 1100 John Glenn Boulevard, Fire Station 14 is strategically positioned to improve response times across Titusville's southern corridor, including key residential communities like Verona and Tranquility Shores, and major transit routes such as U.S. 1, State Road 407, I-95, and access points near the Space Coast Regional Airport.

The new facility is staffed 24/7 by a dedicated crew of three firefighters and an emergency response vehicle. Sharing its perimeter with the Titusville Police Department Headquarters, the station enhances

interagency coordination and reinforces a comprehensive approach to public safety.

"This station allows us to provide faster and more efficient coverage to the southeastern sector of Titusville," said Fire Chief John Hustoles during the ceremony. "It reflects our ongoing mission to ensure that residents and businesses receive the highest standard of fire and emergency medical services."

Meeting the Needs of a Growing Community

As Titusville continues to experience residential and commercial growth, the demand for expanded emergency services has grown in tandem. The opening of Fire Station 14 is part of a broader vision to modernize public safety infrastructure while meeting the city's future needs.

Mayor Connors highlighted the importance of this development: "This station represents more than just bricks and mortar—it's a symbol of our commitment to protect lives, property, and the future of our city."

"Our city is evolving," said Vice Mayor Cole, noting the connection between growth and preparedness, "With that evolution comes a responsibility to ensure our emergency services are equipped to grow with it."

Council Member Jo Lynn Nelson emphasized the community value of the investment: "Fire Station 14 stands as a promise to our residents, a proactive step that ensures families, businesses, and visitors alike are protected and supported."

Fire Station 14 is more than a physical addition—it represents Titusville's proactive approach to safety, growth, and resilience. As the city continues to expand, its leadership remains focused on equipping first responders with the tools, facilities, and resources necessary to serve and protect.

LOCKHEED MARTIN

EXPANDS OPERATIONS IN TITUSVILLE

Global defense technology company Lockheed Martin has announced plans to build a new 225,000 sq. ft. manufacturing and assembly facility in Titusville's Enterprise Park area, as it prepares to fulfill a decades-long contract with the U.S. Navy for the Trident II D5 missile Strategic Weapons Systems. The project is expected to create 300 new jobs for the area, and result in the stationing of over 100 military personnel at the site. In a recent press conference, the company credited assistance it received from the Florida Department of Commerce, the Economic Development Commission of Florida's Space Coast (EDC), and the North Brevard Economic Development Zone (NBEDZ), the latter of which provided a local financial incentive to make the project possible. It is projected that the average annual wage per job created for this project will exceed \$89,000.

Referred to as Project "Topaz" during the search process to identify a site for the production facility, "Topaz" builds upon a 2016 decision by the company to relocate its Fleet Ballistic Missile (FBM) program from California to the Titusville area, a move effected in 2019; that project, which resulted in more than 320 new jobs created locally, also received a financial inducement from the NBEDZ, under the project name "Landmark."



The D5 missile is the most advanced ballistic missile in the world and is currently aboard U.S. OHIO-class and U.K. VANGUARD-class submarines. In 2025, Lockheed Martin will mark 70 years of support to the U.S. Navy as a prime contractor in developing and sustaining the missiles that form the backbone of the nation's sea-based deterrence through the company's FBM program. 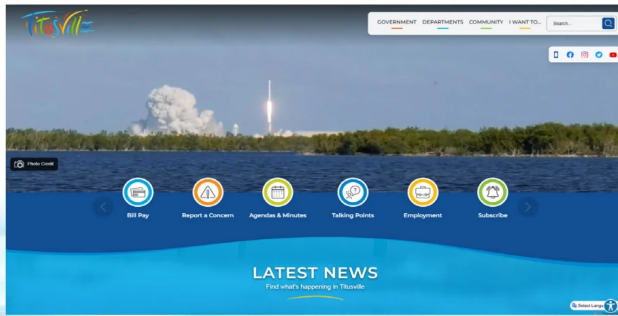

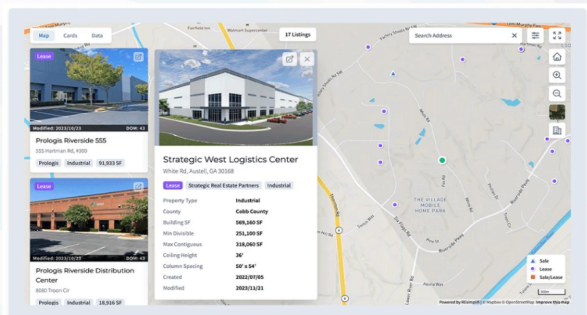

Drive Sober, Drive Safe

The City of Titusville is growing at a tremendous rate with more people calling our city home and joining our growing community. The Kennedy Space Center also brings a healthy amount of tourism to our beautiful city. With the increased number of motorists on our city streets, it is important to acknowledge the dangers of impaired driving.

Drunk driving is a serious offense that endangers not only the driver but also passengers, pedestrians, and other motorists. Alcohol impairs judgment, slows reaction time, and reduces coordination, making it difficult to operate a vehicle safely. With more visitors and residents on the roadways, the risk of alcohol-related accidents increases, making DUI enforcement a critical public safety measure.

Comparing traffic statistics between January 2024 through March 2024 to traffic statistics between January 2025 through March 2025, significant gains in traffic safety were achieved in the side-by-side year analysis.

- Traffic Crashes with Injuries Decreased by 25%.
- Traffic Crashes without Injuries Decreased by 1.5%
- Driving Under the Influence (DUI) Arrests by the Traffic Unit Increased by 83%.

Florida has strict penalties for those convicted of DUI. For a first offense, drivers face fines between \$500 and \$1,000, up to six months

in jail, license suspension for up to a year, and mandatory DUI school. Penalties increase for repeat offenses, including higher fines, longer jail sentences, and the installation of an ignition interlock device. If a DUI results in property damage, injury, or death, the charges escalate to felonies with severe consequences. To avoid these risks, drivers should always plan ahead by designating a sober driver or using alternative transportation.

The Titusville Police Department is dedicated to enforcing traffic laws, educating motorists and keeping our roadways safe and free of impaired drivers. DRIVE SAFE TITUSVILLE!



Crime Prevention Through Environmental Design

Crime Prevention Through Environmental Design (CPTED) is a proactive approach to reducing criminal opportunity via thoughtful design implementation. The main goal of CPTED is to create and design environments where our residents feel safe and secure.

CPTED practitioners consider the following aspects of site design – Natural Surveillance, Natural Access Control, Territorial Reinforcement and Maintenance. An emerging fifth consideration is Social Management. In 2021, Titusville Code Enforcement sent personnel to the Florida Crime Prevention Training Institute to obtain Florida CPTED Practitioner (FCP) designations. Upon receiving FCP designations Code Enforcement staff began developing a CPTED program. Components of this program include complimentary Crime Prevention Through Environmental Design Site Surveys and Consultations, Crime Prevention Through Environmental Design Site Plan Review and a Crime Prevention Through Environmental Design Guidebook that is available in print and electronic format.
